We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by M/s. **Revathi Equipment Limited** (CIN: L29120TZ1977PLC000780) (hereinafter referred as 'the listed entity'), having its Registered Office at Pollachi Road, Malumichampatti P.O, Coimbatore - 641021. 




